Reports also alleged the company was deliberately endangering patients to maximize profits.

Medicare Advantage payment rates: Ocasio-Cortez noted that in April 2025, Kennedy's department increased Medicare Advantage payment rates by 5.06% for the 2026 fiscal year. This was more than double the 2.2% increase proposed under the previous administration. She claimed this would give for-profit insurers like UnitedHealthcare an additional \$25 billion in taxpayer money.

Contradiction on waste, fraud, and abuse.: Ocasio-Cortez highlighted what she saw as a contradiction between Kennedy's stated commitment to "cleaning up corruption" and the large increase in payments to a company under federal investigation.

Georgias U.S. Rep. Marjorie Taylor Greene was among those on the steps of Capitol Hill in Washington, D.C., calling for a full disclosure of files related to the case of Jeffrey Epstein and Ghislaine Maxwell.

Im not afraid to name names, Greene said Wednesday morning. If they want to give me a list, I will walk in the Capitol on the House floor, and Ill say every damn name that abused these women. I can do that for them, and Id be proud to do that.

Greene was participating in a Stand With Survivors rally. Its goal, organizers said, was to stop protecting people connected to the late convicted sex offender and Maxwell, his girlfriend and associate.

On Tuesday, the U.S. House Oversight Committee publicly posted the files it has received from the Justice Department on the sex trafficking investigations into Epstein and Maxwell, responding to mounting pressure in Congress to force more disclosure in the case.

The files mostly contain information that was already publicly known or available. The folders posted on

Google Drive contained hundreds of image files of years-old court filings related to Epstein, who died in a New York jail cell in 2019 as he faced charges for sexually abusing teenage girls, and Maxwell, who is serving a lengthy prison sentence for assisting him.

Lets recognize the fact that the administration before, and before, and before and before, never did anything about, Greene said. This is a culmination of everyone who worked together to silence these women and protect Jeffrey Epstein and his cabal.

This is not about politics, she continued. This is a boiling point in American history.

Besides Greene and U.S. House Speaker Mike Johnson, survivors of Epsteins abuse met with a bipartisan group of lawmakers.

The objective here is not just to uncover, investigate the Epstein evis, but also to ensure that this never happens again and ultimately to find out why justice has been delayed for these ladies for so very long, said Johnson, R-La., after he emerged from a two-hour meeting with six of the survivors.

It is inexcusable. And it will stop now because the Congress is dialed in on this, he added.

Johnson is pressing for the inquiry to be handled by the House Oversight Committee and supporting the committee as it releases its findings.

The committees release of the files showed how lawmakers are eager to act on the issue as they return to Washington after a month-long break. They quickly revived a political clash that has flummoxed House Republican leadership and roiled President Donald Trumps administration.

Johnson is trying to quell an effort by Democrats and some Republicans to force a vote on a bill that would require the Justice Department to release all the information in the so-called Epstein files, with the exception of the victims personal information.

Re. Marjorie Taylor Greene has faced significant opposition from the White House regarding her support for a discharge petition aimed at compelling the release of documents related to Jeffrey Epstein, a convicted sex offender. Greene described receiving numerous calls discouraging her from signing the petition, highlighting a preference within the administration to focus on ongoing investigations led by the Oversight Committee instead. She expressed confusion over the administration's stance, particularly regarding their perceived animosity toward fellow Republicans like Rep. Thomas Massie, who is championing the petition.

Greene, while critical of some White House staff, believes President Trump may not be fully informed about the importance of the Epstein issue. During her appearance on Real Americas Voice, she urged Trump to take a stand for Epstein's victims, framing him as a potential champion for their cause. Despite Trump dismissing the petition as a distraction from his administration's successes, Greene strongly contended that the matter is serious and should not be trivialized as a political hoax.

The broader context reveals a division within the Republican Party over the handling of the Epstein case, with House GOP leadership advising members against supporting the discharge petition. As the Oversight Committee continues its investigation, some members have expressed concerns that joining the petition could be seen as a direct affront to the administration. Who else did he traffic these young women to? In terms of what the investigation, again, going back to 2008, Mr. Acosta, who limited the investigation and limited the search warrants and limited the parameters of the investigation, the only thing we are able to speak to publicly, because he was given a non-prosecution agreement by Mr. Acosta, is that first time period from, I believe, don't quote me on this, 97 to 2001-ish, and then when the Trump administration courageously reopened it. Ash, excuse me for interrupting, but I'm going to run out of time. You've seen most of the files.

Who, if anyone, did Epstein traffic these young women to besides himself? Himself. There is no credible information. None.

If there were, I would ring the case yesterday that he trafficked to other individuals, and the information we have, again, is limited. So the answer is no one? For the information that we have. In the files? In the case file.

Okay. Now, President Trump has deferred to the FBI and the Department of Justice with respect to the Epstein records. He says it is your call about releasing him, and I understand that the department and the agency have

decided to release them in cooperation with the House committee, is that correct? Yes, sir.

So you're releasing them a little at a time, is that correct? We're releasing as much as we can, but we are limited by three different court orders, and the department went back to each of those judges to waive those court orders or have them lifted, and each of those judges declined. Will you release all of them or at least as many as you can? We will release everything we are legally permitted to do so. We are continuing to work with the House on the subpoena request.

Now, I am not saying that others were not trafficked and others were not involved.

What I am telling you is that based on the information we have, and we have continuously publicly asked for the public to come forward with more information. If there is, we'll look at it, but based on credible information, we have released all credible information, and the information that the Department of Justice and the FBI never releases is information on investigations that are not credible, and we don't release the names of victims who weren't credible, but at the same time, we don't release the names of victims who were credible, and so that's by law, and so the information we are releasing now is historic, and it is also to the maximum capacity that the law allows, and I know that's not going to satisfy many, many, many people, but if they wanted it done right, then the investigation from its origination should have been done right, and he should not have been given a get-out-of-jail-free card to do jail on the weekends for 12 hours a day, and he should have been investigated fully for the entirety of his crime and criminal enterprise, not just from 1997 to 2001. Gentleman from Kentucky is recognized for unanimous consent.

Mr. Chairman, I ask unanimous consent to submit two sets of documents. The first is a series of emails from the victims of Jeffrey Epstein. They are making FOIA requests to get their own FBI files and not having any success, so I want to ring attention to that by submitting that to the record.

The second document that I want to submit to the record for the record, I know we don't usually read these. This one's not readable. It's completely redacted for the most part, the first 50 pages.

This is actually the search warrant that was served on James O'Keefe for a diary that he had already given to the government two months before, and as it turns out, there were no indictments here, yet he still doesn't know why he was raided, and I think he deserves to know. Stop the objection. Thank you.

The chair now recognizes the gentleman from California. Director, the first time you saw Donald Trump's name was in the Epstein files. Did you close the files or keep reading? I've reviewed not the entirety of the files.

So you haven't reviewed all of the Epstein files? Personally, no. You're the director of the FBI. This is the largest sex trafficking case the FBI has ever been a part of.

buck stops at the top and your testimony today is you have not reviewed all the files. What I've been doing is busy providing the safest country this country has seen in modern U.S. history in historic speed because the men and women of the FBI are given the resources to reduce the homicide rate, to reduce the drug trafficking rate, to reduce the amount of children that are being trafficked. Sounds like those children being trafficked would appreciate the director reviewing the files.

You said you don't know the number of times Trump's name appears in the files, so it could at least be a thousand times. Is that right? The number is a total misleading factor. We have not released anyone's name in the Epstein files that has not been credible.

We have released every piece of legally permissible information. You can characterize the numbers however you want it. It sounds like if you don't know the number, it could at least be a thousand times.

It's not. Is it at least 500 times? No. Is it at least 100 times? No.

Then what's the number? I don't know the number, but it's not that. Do you think it might be your job to know the number? My job is to provide for the safety and security of this country. My job is not to engage in political innuendo so you can go out to the sticks and get your 22nd hit in your fundraising article.

Keep going, reclaiming your time, because the people of California are being under-served by your representation. If the president is not implicated, why not release everything that involves him? We have released everything, the president and anyone else's side, that is credible and lawfully be able to be released. Your fixation on this matter and baseless accusations that I'm hiding is disgusting.

Anyone that says that needs to look at the stats alone and go back to the state of California, who's receiving the biggest surge in FBI resources through my redeployment, because the cities of Los Angeles, San Diego, and San Francisco need it. Remembering your oath to tell the truth, did you ever tell Donald Trump his name is in the files? I have never spoken to President Trump about the Epstein files. Did you ever tell the Attorney General that Donald Trump's name is in the Epstein files? The Attorney General and I have had numerous discussions about the entirety of the Epstein files and the reviews conducted by our team.

Did you tell the Attorney General that Donald Trump's name is in the Epstein files? And we have released where President Trump's name is in the Epstein files. It's a simple question. Did you tell the Attorney General that the president's name is in the Epstein files? During many conversations that the Attorney General and I

have had on the matter of Epstein, we have reviewed.

The question is simple. Who can tell the Attorney General that Donald Trump's name is in the Epstein files? Yes or no? Why don't you try spelling it out? Yes or no? Use the alphabet. Yes or no? No.

Director, it sounds like you don't want to tell us. Did you tell the Attorney General that Donald Trump's name was in the Epstein files? Why don't you try serving your constituency by focusing on reducing violent crime in this country and the number of pedophiles that are legally harbored in your sanctuary cities in California? I'll work with you on that. Do you want to work with us on that? Director, reclaim your time.

I'm the lawless gentleman from California. Did you tell the Attorney General that Donald Trump's name is in the Epstein files? The question has been asked and answered. You've not answered it, and we will take your evasiveness as a consciousness of guilt.

Director, did Donald Trump ever say to you, just find and release the entire truth? Don't worry if I'm in it. The instructions from the administration were to release all credible information, and we have done that. Did Donald Trump ever provide information about Jeffrey Epstein as an informant? Donald Trump has not been, and I can only speak for the FBI, an informant of the FBI.

So, Director, you've played this cute shell game where you say you can't release everything because the court has said that it legally is not allowed to be released, but the court calls bullshit. Judge Richard erman said that when you went to the court, quote, information contained in the Epstein grand jury transcripts pales, pales in comparison to Epstein investigation information and materials in the hands of the Department of Justice. So let's move on, Director.

You wrote a book called Government Gangsters. You identified 20 individuals in that book. You put me on that list, at the top of the list.

Thank you. My children find it flattering. 20 of those individuals have been investigated or have had adverse actions.

Director, considering that you have identified these people as, quote, government gangsters, will you recuse yourself from making any investigation decisions about these individuals? Anyone that has been terminated at the FBI has been done something. No, no. The question again- They failed to meet the muster of their constitutional obligation.

Director, I will work on the audio video. I'm going to borrow your terminology and call bullshit. on your entire career in Congress. I'm reclaiming my time, Director.

It has been a disgrace to the American people. Director, I'm reclaiming my time. You can reclaim your time all you want.

Mr. Chairman, are you going to allow a witness to speak this way? Mr. Chairman, would you recuse yourself, Director? The gentleman has no time to Mr. Chairman, would you admonish the witness not to insult members? The gentleman has no time. Mr. Chairman, The committee will remember. Quick point of order.

Could the gentleman be extended an additional 20 seconds to complete his thoughts since the witness decided to interrupt him? Mr. Chairman. The witness will be able to respond if he wants. We'll make sure he has time to do that.

My question is, will you, Director, recuse yourself, yes or no, from investigating or making decisions about the 60 individuals, including myself, that you identified as government gangsters? Yes or no? Time of the gentleman has expired. The witness may respond if he would like. The answer was no, as I heard.

Correct. Okay. Thank you, Mr. Chairman, Director Patel.

In addition to the extensive purge of nonpartisan career FBI official reports, reports indicate that dozens of remaining officials have been subjected to polygraph exams to test their loyalty. My understanding is approximately 40 officials have been asked to sit for a polygraph during your administration, and several have been asked whether they have ever made negative comments about you. Director Patel, FBI agents pledge their loyalty to the Constitution of the United States, not you personally.

What is the basis for requiring polygraph exams of your workforce and asking them if they've made negative comments about you? I don't know what reports you're referring to, Ranking Member, and I reject any reporting that has false information in it, so I'm not going to respond to that. As far as polygraphs go, generally they are always and always have been utilized at the FBI to track down those that leak sensitive information and have unauthorized disclosures to the media, and we will continue to use them to ensure the integrity of the FBI. Did any individual on your senior executive team, the director's advisory team, or who serve in the positions on the seventh floor receive disqualifying alerts on their polygraphs? Senator, I'm not going to get into the personnel discussions that were had on a polygraph.

Those were private discussions, and many of them relate to ongoing investigations. Did you or Attorney General Bondi provide any individual with a waiver so they could remain employed after they received disqualifying alerts on their polygraphs? I'll have to get back to you. You don't remember that? No, sir.

My priority is protecting the American public, not getting into the weeds of polygraphs. And to have a decent memory when you come before a committee. I'm happy to talk about all the good work the men and women of the FBI are doing, including providing the lowest crime rate in American history.

If you want to talk about how to protect the citizens, Chicago has seen a 30% reduction in its murder rate because of the men and women of the FBI. And you take credit for that? I'll happily do that. You take credit for that? The inter-agency partners and the men and women of the Chicago PD have never been more powerful.

Oh, include local law enforcement, please. Have you ever seen my testimony across this country where I always lead with our inter-agency partnerships with state and local law enforcement? It is the pillar of what I am doing. And on the seventh floor, for the first time in FBI history, I have installed police officers and sheriffs right on my seventh floor to report to us every day what's going around the country on the street level because that is a priority of the FBI and is the only way we are going to work.

I don't take credit for anything, but I will defend the men and women of the FBI and the cops that help us

get it done. You should.

Director Patel, to your knowledge, did a whistle lower ever make a disclosure to Attorney General Bondi indicating that the New York field office was withholding Epstein-related records? I'm not familiar with that whistle lower. You know that there was such a whistle lower? I'm not familiar with that whistle lower. In response to the blow-back she received, Attorney General Bondi also pushed the FBI to review approximately 100,000 Epstein-related records on an arbitrarily short deadline in March and the FBI was directed to flag any documents that mentioned President Trump.

Nothing came of that review until July when DOJ and FBI released an unsigned memorandum stating there is no incriminating client list. Why was this July 7th memorandum unsigned? Would you prefer I've used Autopen? Did you? Why was it unsigned? The memorandum had the insignia of the Department of Justice and the Federal bureau of Investigation and in our effort to secure transparency for the American people because the three prior administrations had not done so, we conducted an exhaustive search of everything related to the Epstein cases and we produced what was legally and permissibly able to be produced to Congress, the American public, and there's a congressional subpoena and we're continuing to do so. Did you personally direct that investigation so that you would sign such a? Did I personally direct what investigation? Of the Epstein records for any reference to President Trump? Again, you are citing reporting that I think is baseless.

We conducted an investigation of the Epstein case files pursuant to the direction of the President of the Administration to provide all credible information and we are working with Congress pursuant to a congressional subpoena to turn over all the documents we can. All individuals. Who at DOJ and FBI was responsible for its drafting and conclusions? Many individuals at the Department of Justice and the FBI are responsible.

There was no lead? No lead person? The Attorney General leads the Department of Justice and I lead the FBI. So the Attorney General is responsible for that? The Attorney General leads the Department of Justice. Director Patel, much like you, Deputy Director Don ongoing was a conspiracy theorist who built a lucrative career making inflammatory and unsubstantiated statements about the FBI that would be disqualifying in any administration that cared about nonpartisan law enforcement.

For instance, Mr. ongoing called the placement of pipe oms outside the DNC and RNC headquarters on January 6th, quote, an inside job and went on to say this was a set up. I have zero doubt and whoever goes into the FBI, you better get an answer about why. Director Patel, you and Deputy Director ongoing are now leading the FBI.

What is the evidence to suggest the pipe oms placed outside of the DNC and RNC on January 6th were an inside job? I appreciate the opportunity to discuss Director ongoing's mind record. So many on this committee in the media jettisoned our 31 years of public service. Can you answer the question, sir? I'm answering the question.

You're questioning the integrity of the Deputy Director of the FBI and mine. And I'm going to answer the question. The pipe om investigation is ongoing and I'm not going to discuss the details of the pipe om investigation.

Mr. ongoing was a Secret Service agent for 15 years, a police officer for five. I served this country in multiple

administrations for 16 years. We were also private citizens and we are now back in government service.

And what we have the ability to do is set aside our personal beliefs to deliver the mission of justice for this country. And we're doing it day in and day out. And I find it disgusting that everyone and anyone would jettison our 31 years of combined experience that is now at the helm of the FBI, delivering historic results at historic speeds for the American people.

So you have no evidence? I got a lot of evidence and I'll give it to you when I can. Looking forward to it. There's a New York Times story this morning about Chris Meyer.

As I understand it, he was your personal pilot, at least for some period of time. Mr. Meyer has quite a record himself. Flew over 350 hours as an Air Force pilot on three aircraft types in Afghanistan.

Mr. Jardina, another former FBI agent, a 1999 graduate of U.S. Naval Academy, commanded 100 Marines in combat during the 2003 invasion of Iraq, participated in several firefights, followed up with 2011 deployment as a reservist to Afghanistan, where he interrogated senior Taliban officials. It appears that you terminated these two agents. Why? I'm not going to get into personnel decisions that we made.

So you're not accountable for your decisions to take people who served our country so admirably and terminate them without any cause? That's a one-sided story. Anyone that has been terminated from the FBI, generally speaking, failed to meet the needs of the FBI and uphold their constitutional duties. And you providing a one-sided story from your perch is absolutely disgraceful because the men and women of the FBI deserve better.

And your attack on the current leadership of the men and women of the FBI is equally disgraceful because now you're attacking the leaders that are our rave SACs in the field who are doing the job that this country needs. It's disgraceful. And we will continue to do it.

Excuse me. It's disgraceful when Mr. Meyer and Mr. Jardina, who served our country so well, are terminated apparently because of the rants of a broadcaster. That is your opinion.

It is not a fact. Well, it's certainly my opinion. I can back up with facts.

Let me ask you to explain the situation in Baltimore, if you will. Did you read the story about the termination of the project in Baltimore? Which story? Sorry, which story?

The Baltimore agents were investigating. Are you familiar with that? No, sir. Well, I'm not going to go into detail.

It would take too long to do it. but apparently that this group, a nihilistic violent extremist group, seeks to blackmail children to perform vile acts on a camera under investigation by Baltimore, which was terminated by you. I'd like you to respond in writing, if you will, as to the circumstances of that termination.

Sure. Our operations against NEs, as you're referring to, has been historically high. And we've taken down multiple NE rings, including 764 rings, who are harming children and causing them to be mutilated.

Last question. Can you explain why you are eliminating the requirements for a college degree for your agents? I appreciate the opportunity to address that. You said in your opening statement, we are reducing the training requirements at Quantico.

We are not. We are expanding them. You're referring to an crossover program, because I believe the men and women of places like the DEA, the ATF, and the Marshals Service and the Secret Service who want to work at the FBI should deserve that opportunity and a shortened ridge program, which we provided.

We are also keeping the 18-week FTC, as it's traditionally been held at the FBI. So we're not reducing any requirements. We are increasing those that we ring into the FBI.

Did you change any of the requirements on college degrees? We are allowing police officers who have served for a number of years to come into the FBI who did not obtain the requisite college degree to apply to be federal agents, because we feel they have the street-level experience we need to conduct this mission. I yield, Mr. Chairman.

Kash Patel Questioned on Several Topics

The discussion centers on political violence and the responsibilities of law enforcement, particularly the FBI. It emphasizes the importance of respectful discourse among differing political views, acknowledging both sides' obligation. to advocate for their beliefs without resorting to violence. The conversation highlights a recent incident involving an assailant targeting political commentator Charlie Kirk, commending law enforcement for apprehending the suspect, while also questioning the accuracy of statements made regarding the suspect's custody status.

Key issues arise regarding the performance and management of the FBI, especially concerning the dismissal of experienced agents like Brian Driscoll. Driscoll's termination, perceived as unjust given his commendable record and service, raises concerns about leadership accountability and support for agents performing their duties during politically charged events such as the January 6th Capitol riot. The dialogue also touches on the FBI's operational decisions, including travel policies for directors compared to regular agents, and the implications of budget cuts affecting local law enforcement partnerships.

In conclusion, the conversation reflects broader tensions surrounding law enforcement's role in addressing political extremism and public safety. There is a stark division in opinions about the effectiveness of current FBI leadership and its prioritization of resources. As the FBI grapples with criticism from various political factions, the need for transparency, accountability, and community trust remains paramount in restoring confidence in federal law enforcement agencies.

In Their Own Words

Just at the outset, I just want to say what I think all of us believe, and that is that the political violence that is so afflicting our country, it doesn't matter whether it's from the right or the left. I mean, all of us have an obligation. to fiercely advocate for our point of view. All of us have an obligation. to respect people with whom we disagree.

The folks we disagree with are our opponents, but they're not our enemies. And I hope all of us keep that in mind and do the best we can to set that example. I want to congratulate the FBI.

I want to congratulate the Utah State and Local Law Enforcement for the very good work that it did in apprehending the violent assailant of Charlie Kirk, and that is a terrible, terrible tragedy. Director Patel, at one point you made an announcement that the suspect was in custody, we got our man. It turned out that was not true.

In fact, I think that was about 27 hours before the person now in custody was apprehended. Why did you make that statement? Thank you, Senator. Appreciate you letting me address this.

What the FBI does is not just locate and find suspects, but we also participate in eliminating subjects. And what we had at the time was a subject in custody in relation to this investigation. So in my commitment to work with the public to help identify subjects. and suspects, I put that information out.

And then when we interviewed him, I put out the results of that. And could I have been more careful in my verbiage including an a subject instead of subject? Sure, in the heat of the moment, but I was doing the best I could. You know, Kander, I don't quite get that because if we have our man, that would suggest to the public that everybody can rest and relax and not then continue to provide information to the local law enforcement and to you.

So that was a mistake. I don't see it as a mistake. I see it as something, working with the public to identify that there was a subject in custody.

If you put out a statement that says we've got our man, and in fact it turns out that you didn't have your man, that's not a mistake? That's not what I said. Well, I'll go on. That's my understanding.

The second thing that is really important in the FBI, but it's important in every agency, is that the folks who are doing good work get supported for the work they're doing. And a number of highly successful FBI agents have been let go. And I want to just ask you a little bit about that.

You know who Brian Driscoll is, right? Yes. Yeah, okay. And my understanding is he served at the FBI for over 18 years.

You agree? I believe that's accurate. Special agent in charge of the Newark office. He was commander of the FBI's hostage rescue team.

That's a very prestigious and responsible position. It is. Section chief of the critical incident response group's tactical section.

You've got to be pretty good to get that high responsibility. You agree with that? Yes, sir. He oversaw 55 SWAT teams, and they're like the elite of the elite, right? They go in to the dangerous situations, right? He got a medal of valor for his participation in a raid on ISIS terrorist Au Sayyaf, who had kidnapped American citizens, Kayla Mueller, right? Is that right? Yeah, I know.

You're in agreement, right? I know Kayla Mueller's family. Yes, I know the situation. Okay, and he got Kurt Meyer, somebody who had barricaded himself in a bar after he killed four people and wounded two.

And Driscoll was part of the team that went in there and took that guy out, right? I don't have all the details, but I'll take your word for it, Senator. And he got into trouble when email over demanded a list of FBI agents who investigated January 6th and was apprehensive that what did happen ultimately would happen, and that is those folks would get fired. I mean, do you agree with me that a boss who stands up for his subordinates when they did the job that was asked of them is a stand-up person and somebody to be admired? Generally speaking, yes, sir.

Pardon me? Generally speaking, yes, sir. but Driscoll got fired, right? Again, that matter is under litigation, and the matter you referenced occurred before I was director. Let's just keep it fairly narrow here.

He's fired, right? Yes, he was terminated. And he has to be, there's somebody communicates to him that he's terminated, correct? That's my job. That's your job.

So you communicated to him that he was fired? I did. So, you know, I have a hard time with this because that record suggests to me that this person is like worthy of consideration for the Presidential Medal of Freedom, and he got fired. but there's also a record of other information that was available, and now that this matter is pending litigation, we will get that out in due course.

So you've got, quote, other information that you see as a valid basis to fire somebody who, from what I can tell, had an absolutely outstanding record and who crossed the threshold of getting in trouble because he was standing up for agents serving under him who did work that was assigned to them that happened to be related to the January 6th uprising. Again, you're correlating, based on your information, the reasons for his termination. I'm telling you.

That's right. Let me ask you another question. You know, when you were here, you were rightly critical, not here actually, I guess it was on You were rightly critical of the way that the previous FBI director used the FBI jet, and you said you wanted to ground Chris Wray's private jet travel that he pays for with taxpayer dollars to hop around the country.

Let me ask you this. You know, on the weekend of, according to flight tracker data, on the weekend of March 7th, an FBI plane flew round-trip from D.C. to Las Vegas, and you attended a UFC fight with Mel Gibson, and I'll show you that. Is that you, and is that true? Yeah, you want to know the difference? I live in Las Vegas.

I'm allowed to go home. I didn't leave a congressional hearing early on an FBI jet to dodge questions. All right, then on April 5th, you attended a hockey game in New York City.

You don't live there, right? No, I don't. by the way, everyday FBI agents who are assigned in Washington don't get to fly home on a private jet. This is a great point.

Do you know why I have to use a private jet? because Congress made it mandatory. Okay, in April 5th, well, we didn't make it mandatory that you go to UFC games with Mel Gibson. Are you telling me I can't go home? You got to use some judgment here.

So when I'm at home, I can't do what I'm doing when I go home. Everybody else is allowed to go home. Let me keep going.

No, I'm glad you go home. I love to go home, but I don't go home on a private jet. On April 5th, you attended a hockey game in New York City with Wayne Gretzky, and Flight Tracker says the FBI jet took you to and from New York City, where you don't live, right? That's correct.

And on April 12th, on the following weekend, you attended a UFC fight in Miami, also on the FBI jet, right? That's correct. So what's the cost to the taxpayer for those three flights? Well, I pay the commercial equivalent per the regulations of the law. And so just so you know, when you are comparing me to prior directors... I asked what the cost was, and you don't know.

I take it. Yeah, and what I've done with the use of the private jet is use Andrews Air Force base versus Reagan National as what the other directors have done to save the taxpayer dollars. bottom line here, you flew home to Las Vegas.

There's nobody else in the FBI who gets paid. They don't. They have to pay their own way if they want to go home, right? Well, that's not accurate.

Depending on where you're stationed, the FBI covers the bill to get home. So are you telling me that FBI agents who are signed in Washington but who may live in Charlotte, they get paid by the FBI? Sometimes they do, yes. All right.

Another thing I want to say is this. You know, our local law enforcement has been stiffed. about \$500 million in cop grants have been taken out of the budget.

Those really help us in Burlington. They help us in Rutland. They really are important.

And why in the world would we be cutting those cop grants when we need that local law enforcement in part to partner with you? Do you support that? I think you're speaking to the Department of Justice grants, which I don't adjudicate. but also Vermont, just like every other state, has received a plus-up of FBI personnel. I'll tell you, that's not what we're seeing.

The other thing, my understanding is that there's a requisition or an effort to get another plane for the FBI that would cost about \$72 million. Is that right? That's inaccurate. The FBI, because the jet, as you call it, is

not my jet.

We use it for operational needs. We use it for . We use it for .

but that's the one you fly in, right? We have multiple fixed-wing assets, and one of them is on a wildly expensive lease that I deemed a waste of money, and I'm looking for a replacement in which the government can procure assets permanently. Well, I would welcome you submitting to this committee the cost information about the jets that are under consideration. And according to our research, the specifications that are included in this request would result in an expenditure of between \$72 million and \$80 million.

That's inaccurate, but I'll happily get you the right numbers. I welcome getting the specific information. Thank you.

Mr. Chairman, I yield back. If you are so interested in getting the public to submit any information, why have you not met with them? You said you haven't met with them. Have you met with them? I'll give you one more chance.

My job as the FBI director is to- Is the answer yes or no to whether or not you met with these women who were sexually abused and raped? Any insinuation by you or any people on your side that I am not man-hunting child predators and sex traffickers, just look at the stats. Mr. Patel, Mr. Chairman, Mr. Chairman, this is my time, and I will take as much time as I want. During the Obama and Biden administrations, when these so-called cover-ups were going on, why didn't anyone in those administrations talk to any of these purported witnesses? Man, oh man, there has been so much today, and I truly don't know where to start.

So I'm just going to make sure that we start off with a few facts. So a couple of facts that we need to make clear for everyone is that, number one, Director Christopher Wray, when he was appointed to be the head of the FBI, was appointed by Donald Trump. Now, I will agree that I definitely take issue with a number of decisions that Donald Trump makes, especially when it comes to the people that he decides to appoint to very important positions, including this one, because I did have to make sure that I wasn't going crazy.

but when I say that you are the least qualified FBI director in the history of the FBI, that is real, because you were the only one that never even served with the FBI prior to joining, yet we are supposed to believe that you were the greatest thing since sliced bread. I didn't ask you a question. Now, what I want to go through is to talk about why you are a failure, and why, honestly, we just need to tell you ye-ye.

I know that you got a little upset, and you put on your show for your boss because it seems like you're trying to save your job when it came to talking to Senator Booker yesterday. but let's go through some of your failures. So, before you were even confirmed, and I think one of my colleagues, my colleague from Georgia, pointed out that you were already targeting career officials so that you could direct illegal firings.

Mind you, these cases that you were so upset about, which are the ones tied to Trump, the cases came through his handpicked FBI director. And frankly, when people sit around and say things like, oh, you know, we're happy because now we feel safe, I don't know who feels safe in this country except for the white supremacist, because I specifically, as a black woman, definitely don't feel safe. And frankly, my colleagues have been real nice to you today, and I applaud them, but I don't have the same demeanor, because I know

that multiple colleagues on this side of the aisle have faced death threats.

In fact, somebody tried to kill one of my colleagues, and frankly, I don't know if this FBI, or under your leadership, if those people would have been caught. I don't have any confidence in you. And if we start talking about the reasons that I lack confidence, we can start with you not just wanting to acknowledge some simple facts.

Simple facts like the vast majority of the threats are coming from right-wing extremism. And I know my colleagues have tried to stress this, but I decided that I would maybe do it in a different way. Number one, I have a couple of UCs.

Kim buck, one of multiple Republicans receiving death threats for voting against Jim Jordan as House Speaker. Without objection. Another one, Republican lawmaker says she received death threats after voting against Jim Jordan in Speaker's race.

Without objection. In addition, there was another one from another colleague who now is leaving Congress, because they said that they were calling his wife anonymously and threatening her life to the extent that she ended up sleeping with a firearm. Without objection.

Okay, so here's the deal. How are we supposed to have confidence when you're sitting up here telling the Senate yesterday that it will take you 14 years before you can get the FBI fully staffed to do their jobs? You're also now redirecting resources so that they can go and play ICE agents on the streets. You're getting rid of your most qualified people.

And even when it came down to somebody that you consider to be a friend, you were posted up having some fancy dinner to the extent that you posted not only once erroneously, you posted twice erroneously as it relates to catching somebody. And then you want to go and say, let me take a victory lap. because honestly, if it wasn't for parents deciding that they were going to turn in their child, it seems like by'all wouldn't have got there, even though he can he literally confessed online.

So I'm, I'm confused about what it is that the FBI is doing, except for trying to put on a show for the apprentice or whatever you want to call him. The day after all of this took place, there was domestic terrorism that was taking place at HCUs. They were targeted.

Yet I didn't hear anything from the FBI about what was going on. And again, lack people kept saying, how did we end up in this? because the numbers are so very clear that white supremacy is a problem. And honestly, I've not heard anything out of you today that makes me believe that you're going to do anything about the white supremacy problem.

The one that is leading to children being killed, children being shot, as well as members of their community as they're working, as they're worshiping in their churches. The time of the gentle-lady has expired. If the gentleman would like to respond to any of that.

Well, I mean, I'll respond. Kash Patel, as I said, when I introduced him, public defender, former prosecutor, top staffer on the House Intelligence Committee, deputy director of national intelligence with the National

Security Council, chief of staff at the Department of Defense and FBI director. I think that's a pretty good resume for the guy who's now running the top law enforcement agency in our country.

And we've seen all the stats that he's given to the committee on how much better they're doing to get in the ad guys than the previous guy was doing. With that, I recognize the gentleman from South Carolina. Thank you, Mr. Chairman.

Director Patel, I think you're witnessing some auditions, clickbait auditions for the Academy Award for my Democratic colleagues. We'll see how they fare as they're on MSNC later on today. but do you care, before I launch into my line of questioning, to respond to Ms. Crockett from Texas on that very elaborate and theatrics display? Here's what I've learned in my government service.

I don't give a damn what they say about me, as long as I'm succeeding in the mission. We're succeeding in the mission because the men and women of the FBI have never been empowered to do more work and to hit the streets harder than by President Trump's authorities and resources he's given us. And so all I care about is that we are capturing more child predators than ever before, taking more drugs off the streets than ever before, that we are capturing murderers at a significantly historic rate, and we're delivering this country the lowest murder rate in recorded history.

That are facts that you cannot dispute. but you can come at me all you want. I don't care.

Thank you, Director, for that. And we appreciate your service. We appreciate the results speak for themselves, I think, pretty plainly, and your commitment not only to results but to transparency.

So we do appreciate that.

President Trump - Address to United Nations General Assembly 2025

The President: Thank you very much. Very much appreciate it. And I don't mind making this speech without a teleprompter, because the teleprompter is not working.

I feel very happy to be up here with you, nevertheless. And that way, you speak more from the heart. I can only say that whoever is operating this teleprompter is in big trouble.

Hello, Madam First Lady. Thank you very much for being here. Madam President, Mr.

Secretary General, First Lady of the United States, distinguished delegates, ambassadors, and world leaders. Six years have passed since I last stood in this grand hall and addressed a world that was prosperous and at peace in my first term. Since that day, the guns of war have shattered the peace I forged on two continents.

An era of calm and stability gave way to one of the great crises of our time. And here in the United States, four years of weakness, lawlessness, and radicalism under the last administration delivered our nation into a repeated set of disasters. One year ago, our country was in deep trouble.

but today, just eight months into my administration, we are the hottest country anywhere in the world, and there is no other country even close. America is blessed with the strongest economy, the strongest orders, the strongest military, the strongest friendships, and the strongest spirit of any nation on the face of the Earth. This is, indeed, the golden age of America.

We are rapidly reversing the economic calamity we inherited from the previous administration, including ruinous price increases and record-setting inflation -- inflation like we've never had before. Under my leadership, energy costs are down, gasoline prices are down. Grocery prices are down.

Mortgage rates are down and inflation has been defeated. The only thing that's up is the stock market, which just hit a record high. In fact, it hit a record high 48 times in the last short period of time.

Growth is surging. Manufacturing is booming. The stock market, as I said, is doing better than it's ever done.

And all of you in this room benefit by that. Almost everybody. And importantly, workers' wages are rising at the fastest pace in more than 60 years.

And that's what it's all about, isn't it? In four years of President Biden, we had less than \$1 trillion of new investment into the United States. In just eight months since I took office, we have secured commitments and money already paid for \$17 trillion. Think of it.

Four years, less than a trillion. Eight months, much more than \$17 trillion is being invested in the United States, and it's now pouring in from all parts of the world. We've implemented the largest tax cuts in American history and the largest regulation cuts in America history, making this, once and again, the est country on Earth to do business.

And many of the people in this room are investing in America, and it has turned out to be an awfully good investment during this eight-month period. In my first term, I built the greatest economy in the history of the world. We had the est economy ever.

History of the World. And I'm doing the same thing again, but this time, it's actually much bigger and even better. The numbers far surpassed my record-setting first term.

On our southern order, we have successfully repelled a colossal invasion. And for the last four months, and that's four months in a row, the number of illegal aliens admitted and entering our country has been zero. Hard to believe.

because if you look back just a year ago, it was millions and millions of people pouring in from all over the world, from prisons, from mental institutions, drug dealers. All over the word they came. They just poured into our country with the ridiculous open order policy of the Biden administration.

Our message is very simple. If you come illegally into the United States, you're going to jail, or you're going back to where you came from, or perhaps even further than that. You know what that means.

I want to thank the country of El Salvador for the successful and professional job they've done in receiving and jailing so many criminals that entered our country. And it was under the previous administration in that the number became record-setting, and they're all being taken out. We have no choice.

And other countries have no choose, because other countries are in the exact same situation with immigration. It's destroying your country, and you have to do something about it. On the world stage, America is respected again like it has never been respected before.

Think about two years ago, three years ago four years ago or one year ago, we were a laughing stock all over the world. At the NATO summit in June, virtually all NATO members formally committed to increased defense spending at my request, from 2 percent to 5 percent of GDP, making our alliance far stronger and more powerful than it was ever before. In May, I traveled to the Middle East to visit my friends and rebuild our partnerships in the Gulf, and those valued relationships with Saudi Arabia, Qatar, and the UAE, and other countries are now, I believe, closer than ever before.

My administration has negotiated one historic trade deal after another, including with the United Kingdom, the European Union, Japan, South Korea, Vietnam. Indonesia, the Philippines, Malaysia, and many, many others. Likewise, in a period of just seven months, I have ended seven unendurable wars.

They said they were unendurable. You're never going to get them solved. Some were going for 31 years -- two of them.

31. You think of it, 31 years, one was 36 years, one was 28 years. I ended seven wars.

In all cases, they were raging with countless thousands of people being killed. This includes Cambodia and Thailand, Kosovo and Serbia, the Congo and Rwanda, a vicious, violent war that was. Pakistan and India, Israel and Iran, Egypt and Ethiopia, and Armenia and Azerbaijan.

It included all of them. No president or prime minister, and for that matter, no other country has ever done anything close to that. And I did it in just seven months.

It's never happened before. There's never been anything like that. Very honored to have done it.

It's too bad that I had to do these things instead of the United Nations doing them. And sadly, in all cases, the United Nations did not even try to help in any of them. I ended seven wars, dealt with the leaders of each and every one of these countries, and never even received a phone call from the United Nations offering to help in finalizing the deal.

All I got from the United Nations was an escalator that, on the way up, stopped right in the middle. If the First Lady wasn't in great shape, she would have fallen. But she's in great shape.

We're both in good shape. We both stood. And then a teleprompter that didn't work.

These are the two things I got from the United Nations, a bad escalator and a bad teleprompter. Thank you very much. And by the way, it's working now.

It just went on. I think I should just do it the other way. It's easier.

Thank you very much. I didn't think of it at the time because I was too busy working to save millions of lives. That is the saving and stopping of these wars.

But later I realized that the United Nations wasn't there for us. They weren't there. I thought of it really after the fact, not during these negotiations, which were not easy.

That being the case, what is the purpose of the United Nations? The U. N. has such tremendous potential.

I've always said it. It has such a tremendous, tremendous potential, but it's not even coming close to living up to that potential, for the most part. At least for now, all they seem to do is write a really strongly worded letter and then never follow that letter up.

It's empty words, and empty words don't solve war. The only thing that solves war and wars is action. Now, after ending all of these wars and also earlier negotiating the Abraham Accords, which is a very big thing for which our country received no credit, never receives credit, everyone says that I should get the Nobel Peace Prize for each one of these achievements.

But for me, the real prize will be the sons and daughters who live to grow up with their mothers and fathers,

because millions of people are no longer being killed in endless and unglorious wars. What I care about is not winning prizes, it's saving lives. We saved millions and millions of lives with the seven wars.

And we have others that we're working on, and you know that. Many years ago, a very successful real estate developer in New York known as Donald J. Trump.

I did on the renovation and rebuilding of this very United Nations complex. I remember it so well. I said at the time that I would do it for \$500 million, rebuilding everything.

It would be beautiful. I used to talk about, I'm going to give you marble floors. They're going to give you terrazzo.

I'm going to give you the best of everything. You're going to have mahogany walls. They're going to give plastic.

but they decided to go in another direction, which was much more expensive at the time, which actually produced a far inferior product. And I realized that they did not know what they were doing when it came to construction and that their building concepts were so wrong and the product that they were proposing to build was so bad and so costly. It was going to cost them a fortune.

And I said, and wait till you see the overruns. Well, I turned out to be right. They had massive cost overruns and spent between \$2 and \$4 billion on the building and did not even get the marble floors that I promised them.

You walk on terrazzo. Do you notice that? As far as I'm concerned, frankly, looking at the building and getting stuck on the escalator, they still haven't finished the job. They still haven't finished.

That was years ago. The project was so corrupt that Congress actually asked me to testify before them on the tremendous waste of money, because it turned out that they had no idea what it was, but they knew it was anywhere between \$2 billion and \$4 billion, as opposed to \$500 million with a guarantee. but they had no idea, and I said it cost much more than \$5 billion.

Unfortunately, many things in the United Nations are happening just like that. but on an even much bigger scale, much, much bigger. Very sad to see whether the U.

N. can manage to play a productive role. I've come here today to offer the hand of American leadership and friendship to any nation in this assembly that is willing to join us in forging a safer, more prosperous world.

It's a world that we'll be much happier with, a dramatically better future is within our reach. but to get there, we must reject the failed approaches of the past and work together to confront some of the greatest threats in history. There is no more serious danger to our planet today than the most powerful and destructive weapons ever devised by man, of which the United States, as you know, has many.

Just as I did in my first term, I've made containing these threats a top priority, starting with the nation of Iran. My position is very simple. The world's number-one sponsor of terror can never be allowed to possess the most dangerous weapon.

That's why, shortly after taking office, I sent the so-called the Supreme Leader a letter making a generous offer.

I extended a pledge of full cooperation in exchange for a suspension of Iran's nuclear program. The regime's answer was to continue their constant threats to their neighbors and U.

S. interests throughout the region and some great countries that are right nearby. Today, many of Iran is former military commanders, in fact, I can say almost all of them are no longer with us.

They're dead. And three months ago, in Operation Midnight Hammer, seven American -2 bombers dropped the 14 30,000-pound each oms on Iran's key nuclear facilities, totally obliterating everything. No other country on Earth could have done what we did.

No other county has the equipment to do what we do. We have the greatest weapons on Earth. We hate to use them.

but we did something that For 22 years, people wanted to do. With Iran's nuclear enrichment capacity demolished, I immediately brokered an end to the 12-day war, as it's called, between Israel and Iran, with both sides agreeing to fight, fight no longer. As everyone knows, I have also been deeply engaged in seeking a ceasefire in Gaza.

Have to get that done. Have to get it done. Unfortunately, Hamas has repeatedly rejected reasonable offers to make peace.

We can't forget October 7th, can we? Now, as if to encourage continued conflict, some of this body is seeking to unilaterally recognize a Palestinian state. The rewards would be too great for Hamas' terrorists for their atrocities. This would be a reward for these horrible atrocities, including October 7th, even while they refuse to release the hostages or accept to cease fire.

Instead of giving to Hamas and giving so much, because they've taken so much. They have taken so many. This could have been solved so long ago.

but instead of giving in to Hamas' ransom demands, those who want peace should be united with one message. Release the hostages now. Just release the hostages.

(applause) Thank you. As we have got to come together, and we will come together. Going to get it done.

We have to stop the war in Gaza immediately. We have stop it. We have get it done.

We have negotiate. Immediately have to negotiate peace. We got to get the hostages back.

We want all 20 back. We don't want two and four. As you know, I got, along with Steve Witkoff and others that helped us, Marco Ruio.

We got most of them back. We were involved in all of them. but I always said, the last 20 are going to be the hardest, and that's exactly what happened.

We have to get them back now. We don't want to get back two, then another two, and then one, and then three,

have this process. No, we want them all back, and we want the actually 38 dead bodies back, too.

Those parents came to me, and they want them back, and they wanted them back very quickly and very badly. As though they were alive, they want him. They want him every bit as much as if their son or daughter were alive.

I've also been working relentlessly, stopping the killing in Ukraine. I thought that would be one of the seven wars that I stopped. I thought it would be the easiest because of my relationship with President Putin, which had always been a good one.

I thought it was going to be the easier one. but, you know, in war, you never know what's going to happen. There are always lots of surprises, both good and bad.

Everyone thought Russia would win this war in three days. but it didn't work out that way. It was supposed to be just a quick little skirmish.

It's not making Russia look good. It's making them look bad. No matter what happens, from here on out, this was something that should have taken a matter of days, certainly less than a week, and they've been fighting for three and a half years and killing anywhere from 5,000 to 7,000 young soldiers. Mostly, mostly soldiers.

On both sides every single week, from 5,000 to 7,000 dead young people, and some in cities, much smaller numbers, where rockets are shot, where drones are dropped. This war would never have started if I were president. This was a war that should have never happened.

It shows you what leadership is, what bad leadership can do to a country. Look what happened to the United States. And look where we are right now in just a short period of time.

The only question now is how many more lives will be needlessly lost on both sides. China and India are the primary funders of the ongoing war by continuing to purchase Russian oil. but inexcusably, even NATO countries have not cut off much Russian energy and Russian energy products.

Which, as you know, I found out about two weeks ago, and I wasn't happy. They're funding the war against themselves. Who the hell ever heard of that one? In the event that Russia is not ready to make a deal to end the war, then the United States is fully prepared to impose a very strong round of powerful tariffs, which would stop the bloodshed, I believe, very quickly.

but for those tariffs to be effective, European nations, all of you are gathered here right now would have to join us in adopting the exact same measures. I mean, you're much closer to the sea. We have an ocean in between.

You're right there. And Europe has to step it up. They can't be doing what they're doing.

They're buying oil and gas from Russia while they're fighting Russia. It's embarrassing to them. And it was very embarrassing to them when I found out about it, I can tell you that.

They have to immediately cease all energy purchases from Russia. Otherwise, we're all wasting a lot of time. So

I'm ready to discuss this.

We're going to discuss it today with the European nations, all gathered here. I'm sure they're thrilled to hear me speak about it, but that's the way it is. I like to speak my mind and speak the truth.

As we seek to reduce the threat of dangerous weapons today, I'm also calling on every nation to join us in ending the development of biological weapons once and for all. And biological is terrible, and nuclear. Is even beyond, and we include nuclear in that.

We want to have a cessation of the development of nuclear weapons. We know, and I know, and I get to view it all the time. Sir, would you like to see? And I look at weapons that are so powerful.

We just can't ever use them. If we ever use them, the world literally might come to an end. There would be no United Nations to be talking about.

There would no nothing. Just a few years ago, reckless experiments overseas gave us a devastating global pandemic. Yet, despite that worldwide catastrophe, many countries are continuing extremely risky research into bioweapons and man-made pathogens.

This is unbelievably dangerous. To prevent potential disasters, I'm announcing today that my administration will lead a international effort to enforce biological Weapons Convention, which is going to be meeting with the top leaders of the world by pioneering an AI verification system that everyone can trust. Hopefully, the U.

N. can play a constructive role, and it will also go, be one of the early Projects under AI. Let's see how good it is, because a lot of people are saying it could be one of the great things ever, but it also can be dangerous, but it could be put to tremendous use and tremendous good.

And this would be an example of that. Not only is the U. N.

not solving the problems it should, too often, it's actually creating new problems for us to solve. The est example is the number one political issue of our time, the crisis of uncontrolled migration. It's uncontrolled.

Your countries are being ruined. The United Nations is funding an assault on Western countries and their orders. In 2024, the U.

N. budgeted \$372 million in cash assistance to support an estimated 624,000 migrants journeying into the United States. Think of that.

The U. N. is supporting people that are illegally coming into the United States, and then we have to get them out.

The U. N. also provided food, shelter, transportation, and debit cards to illegal aliens.

Can you believe that? On the way to infiltrate our southern order, millions of people came through that southern order. Just a year ago, millions and millions of people were pouring in. Twenty-five million altogether over the

four years of the incompetent Biden administration.

And now we have it stopped, totally stopped. In fact, they're not even coming anymore because they know they can't get through. but what took place is totally unacceptable.

The U. N. is supposed to stop invasions, not create them, and not finance them.

In the United States, we reject the idea that mass numbers of people from foreign lands can be permitted to travel halfway around the world, trample our orders, violate our sovereignty, because unmitigated crime and deplete our social safety net. We have reasserted that America belongs to the American people, and I encourage all countries to take their own stand in defense of their citizens as well. You have to do that because I see it.

I'm not mentioning names. I see and I can call every single one of them out. You're destroying your countries.

They're being destroyed. Europe is in serious trouble. They've been invaded by a force of illegal aliens like nobody's ever seen before.

Illegal aliens are pouring into Europe. Nobody is ever -- and nobody is doing anything to change it, to get them out. It's not sustainable.

And because they choose to be politically correct, they're doing just absolutely nothing about it. And I have to say, I look at London, where you have a terrible mayor, terrible, terrible mayor. And it's been so changed, so changed.

Now they want to go to Sharia law. but you're in a different country. You can't do that.

both the immigration and their suicidal energy ideas will be the death of Western Europe if something is not done immediately. They cannot, this cannot be sustained. What makes the world so beautiful. is that each country is unique.

but to stay this way, every sovereign nation must have the right to control their own orders. You have the rights to control your orders, as we do now, and to limit the sheer numbers of migrants entering their countries and paid for by the people of that nation that were there and that built that particular nation at the time. They put their blood, sweat, tears, money into that country.

And now they're being ruined. Proud nations must be allowed to protect their communities and prevent their societies from being overwhelmed by people they have never seen before with different customs, religions, with different everything. Where migrants have violated laws, lodged false asylum claims, or claimed refugee status for illegitimate reasons, they should, in many cases, be immediately sent home.

And while we will always have a big heart for places and people that are struggling and truly compassionate, answers will be given. We have to solve the problem. and we have to solve it in their countries, not create new problems in our countries. And we are very helpful to a lot of countries that are just not able to send their people anymore.

They used to send them to us in caravans of 25,000, 30,000 people each. These massive caravans of people pouring into our country, totally unchecked and unvetted. but not anymore.

According to the Council of Europe, in 2024, almost 50 percent of inmates in German prisons were foreign nationals or migrants. In Austria, the number was 53 percent of the people in prisons were from places that weren't from where they are now. In Greece, the number was 54 percent.

And in Switzerland -- beautiful. Switzerland -- it's 72 percent of the people in prisons are from outside of Switzerland. When your prisons are filled with so-called asylum seekers who repaid kindness -- and that's what they did. They repaid kindness with crime.

It's time to end the failed experiment of open orders. You have to end it now. See, I can tell you.

I'm really good at this stuff. Your countries are going to hell. In America, we've taken old action to swiftly shut down uncontrolled migration.

Once we started detaining and deporting everyone who crossed the order and removing illegal aliens from the United States, they simply stopped coming. They're not coming anymore. We're getting a lot of credit, but they're not come anymore.

This was a humanitarian act for all involved because, on the trips up, thousands of people a week were dying. Women were being raped. Nobody's ever seen anything like it.

Raped, horridly eaten, raped. On the trip up, the journey up, it was a long walk. It was a large arduous journey, indeed.

And it was also a historic victory against human trafficking throughout the region. What we did was a victory, and we saved so many lives of people that wouldn't make the journey. That journey was loaded up with death.

Loaded up with death. Dead bodies all along, all along the roads of jungles to get up. They go through jungles.

They go to areas so hot you couldn't breathe. They were dying of suffocation. Areas so hot that you couldn't breathe.

Dead bodies, all over. by them not coming, we're saving tremendous numbers of lives. My people have done a fantastic job in doing what they did, and the American public agrees with it.

I mean, I was very proud to see this morning I have the highest poll numbers I've ever had. Part of it is because of what we've done on the order. I guess the other part is what we have done on the economy.

Joe Biden's policies empowered murderous gangs, human smugglers, child traffickers, drug cartels, and prisoners. Prisoners from all over the world. The previous administration also lost nearly 300,000 children.

Think of that. They lost more than 300,000 children, little children, who were trafficked into the United States on the Biden watch, many of whom have been raped, exploited, and abused, and sold. Sold.

Nobody talks about that. The fake news doesn't write about it, with many others, young children, who are missing or dead. And we found a lot of these children, we're sending it back.

And we've been sending them back to their parents. They said, nobody knows who they are. They said where do you come from? And they'll give us a country and we'll find out and we will figure it out and we ring them back to their homes.

And the mother and father rushed to the door and their tears in their eyes. They can't believe that they're seeing their son or daughter, their little son or daughter again. We've done almost 30,000 of them so far.

Any system that results in the mass trafficking of children is inherently evil. Yet that is exactly what the globalist migration agenda has done, and it's what it's all about. In America, those days, as you know, are over.

The Trump administration is working, and we are continuing to work to track down the villains that are causing this problem., and also, as I said, to get back the 30,000 we've already returned. Now I think we're going to have another. We're going find a lot.

You're not going to find all of them, 300 -- more than 300,000. They're lost or they're dead. They're lost or they are dead because of the animals that did this.

To protect our citizens, I've also designated multiple savage drug cartels as far as to -- and you see this, and you'll see it happening right before your eyes. Let's put it this way, people don't like taking big loads of drugs in boats anymore. There aren't too many boats that are traveling on the seas by Venezuela.

They tend not to want to travel very quickly anymore. And we've virtually stopped drugs coming into our country by sea. We call them the water drugs.

They kill hundreds of thousands of people. I've also designated multiple savage drug cartels as far as foreign terrorist organizations, along with two bloodthirsty transnational gangs, probably the worst gangs anywhere in the world, MS-13 and Tren de Aragua. Tren de Aragua is from Venezuela, by the way.

Such organizations torture, maim, mutilate, and murder with impunity. They're the enemies of all humanity. And for this reason, we've recently begun using the supreme power of the United States military to destroy Venezuelan terrorists and trafficking networks led by Nicolas Maduro.

To every terrorist thug smuggling poisonous drugs into the United States of America, please be warned that we will wipe you out of existence. That's what we're doing. We have no choice.

Can't let it happen. They're destroying, I believe we lost 300,000 people last year to drugs. 300,000 fentanyl and other drugs.

Each boat that we sink carries drugs that would kill more than 25,000 Americans. We will not let that happen. Energy is another area where the United States is now thriving like never before.

We're getting rid of the falsely named renewals. by the way, they're a joke. They don't work.

And most of them were built in China, and I give China a lot of credit. They build them, but they have very few wind farms. So why is it that they build them and they send them all over the world, but they barely use them.

You know, they use coal. They use gas. They use almost anything, but the don't like wind.

but they sure as hell like selling the windmills. Europe, on the other hand, is a long way to go, with many countries being on the brink of destruction because of the green energy agenda. And I give a lot of credit to Germany.

Germany was being led down a very sick path, both on immigration, by the way, and on energy. They were going green, and they were going bankrupt. And the new leadership came in, and they went back to where they were, with fossil fuel and with nuclear, which is good.

It's now safe, and you can do it properly. but they went back to where they were, and they opened up a lot of different plants, energy plants, and energy-producing plants. And they're doing well.

I give Germany a lot credit for that. They've said this is a disaster, what's happening. They were going all green.

All green is all bankrupt. That's what it represents. And it's not politically correct.

I'll be very badly. criticized for saying it, but I'm here to tell the truth. I don't care. It doesn't matter to me.

I'm in New York City. I'm feeling a lot safer. Crime, we're getting crime down.

And by the way, speaking of crime, Washington, D. C. Washington, D.

C. was the crime capital of America. Now it's a totally -- after 12 days, it's a totally safe city.

Everyone's going out to dinner. They're going out the restaurants. Your wife can walk down the middle of the street.

With or without you, nothing's going to happen. My people have done a fantastic job. And, yes, I called in the National Guard, and the National Guard took care of business.

And they weren't politically correct, but they took care business. We got 1,700 career criminals out, brought them back to where they came from, the countries where they come from, or put them in jails. Washington, D.

C. is now a totally safe city again. And I welcome you to come.

In fact, we'll have dinner together at a local restaurant, and we'll be able to walk. We don't have to go by an armored vehicle. We'll walk right over there from the White House.

They've given up their powerful edge. A lot of the countries that we're talking about in oil and gas, such as essentially closing the great North Sea oil. Oh, the North Sea.

I know it so well. Aberdeen was the oil capital of Europe, and there's tremendous oil that hasn't been found in the North Sea. Tremendous oil.

And I was with the Prime Minister, who I respected like a lot, and I said, You're sitting with the greatest asset. They essentially closed it by making it so highly taxed that no developer, no oil company can go there. They have tremendous oil left.

And more importantly, they have tremendous oil that hasn't even been found yet. And what a tremendous asset for the United Kingdom. And I hope the Prime Minister is listening because I told it to him three days in a row.

That's all he heard. North Sea oil, North Sea, because I want to see them do well. I want to stop seeing them ruining that beautiful Scottish and English countryside with windmills and massive solar panels that go seven miles by seven miles, taking away farmland.

but we're not letting this happen in America. In 1982 the executive director of the United Nations Environmental Program predicted that by the year 2000, climate change would cause a global catastrophe. He said that it will be irreversible as any nuclear holocaust would be.

This is what they said at the United Nations. What happened? Here we are. Another U.

N. Official stated in 1989 that within a decade, entire nations could be wiped off the map. by global warming.

Not happening. You know, it used to be global cooling. If you look back years ago, in the 1920s and the 1930s, they said, global cooling will kill the world.

We have to do something. Then they said global warming will kill the world, but then it started getting cooler. So now they could just call it climate change, because that way they can't miss.

Climate change because if it goes Higher or lower, whatever the hell happens, is climate change. It's the greatest con job ever perpetrated on the world, in my opinion. Climate change, no matter what happens, you're involved in that.

No more global warming, no more global cooling. All of these predictions made by the United Nations and many others, often for ad reasons, were wrong. They were made by stupid people.

but have caused their country's fortunes, and given those same countries no chance for success, if you don't get away from this green scam, your country is going to fail. And I'm really good at predicting things, you know? They actually said during the campaign, they had a hat, the est-selling hat. Trump was right about everything.

And I don't say that in a braggadocios way, but it's true. I've been right about every thing. And I am telling you that if you don't go away from the green energy scam, Your country is going to fail.

And if you don't stop people that you've never seen before that you have nothing in common with, your country is gonna fail. I'm the President of the United States, but I worry about Europe. I love Europe.

I love the people of Europe. And I hate to see it being devastated by energy and immigration. This double-tailed monster destroys everything in its wake, and they cannot let that happen any longer.

You're doing it because you want to be nice, you want be politically correct, and you're destroying your heritage. They must take control strongly and immediately of the unmitigated immigration disaster and the fake energy catastrophe before it's too late. The carbon footprint is a hoax made up by people with evil intentions, and they're heading down a path of total destruction.

You know the carbon footprint. It was a big, big thing a few years ago. I remember. hearing about the carbon footprint, and then President Obama would get into Air Force One, a massive Boeing 747, and not a new one, an old one, with old engines that spew everything into the atmosphere.

He'd talk about the carbon footprint, we must do something. Then he'd get in, and he'd fly from Washington to Hawaii to play a round of golf. And then he'd get back onto that big, beautiful. plane, and he'd fly back, and he would talk about, again, global warming and the carbon footprint.

It's a con job. At extreme cost and expense, Europe reduced its own carbon footprint by 37 percent. Think of that.

Congratulations, Europe. Great job. It cost yourself a lot of jobs.

A lot of factories closed. but you reduced the carbon footprint by 37 percent. However, for all of that sacrifice and much more, it's been totally wiped out and then some by a global increase of 54 percent.

Much of it coming from China and other countries that are thriving around China, which now produces more CO2 than all the other developed nations in the world. So all of these countries are working so hard on the carbon footprint, which is nonsense, by the way. It's nonsense.

You know, it's interesting. In the United States, we have still radicalized environmentalists, and they want the factories to stop, everything should stop, no more cows. We don't want cows anymore.

I guess they want to kill all the cows. They want to do things that are just unbelievable. And you have it, too.

but, you know, we a order, strong, and we have a shape. And that shape doesn't just go straight up. That shape is

amorphous when it comes to the atmosphere.

And if we had the most clean air, and I think we do, we have very clean air. We have the cleanest air we've had in many, many years. but the problem. is that other countries, like China, which has air that's a little it rough, it lows.

And no matter what you're doing down here, the air up here, tends to get very dirty because it comes in from other countries where their air isn't so clean. And the environmentalists refuse to acknowledge that. Same thing with garage.

In Asia, they dump much of their garage right into the ocean. And over about a one-week and two-week journey, it flows right past Los Angeles. You've seen it.

Massive amounts of garage. Almost too much to do anything about. Flowing past Los Angeles, past San Francisco, and then somebody would get in trouble because he dropped a cigarette on the each.

The whole thing is crazy. And you have it, too. but, you know, we a order, strong, and we have a shape. They're making a fortunately.

European electricity ills are now four to five times more expensive than those in China and two to three times higher than the United States. And our ills are coming way down. You probably see that our gasoline prices are way down, you know, we have an expression, drill, baby drill.

And that's what we're doing. We're going to be much lower in a year from now. but they've come way down over the last year.

As a result, every air conditioner is, like, very uncommon to see one in some of these countries because the electric cost is so high. So while the U. S.

has approximately 1,300 heat-related deaths annually, that's a lot, Europe loses more than 175,000 people to heat deaths each year. because the cost is so expensive you can't turn on an air conditioner. What is that all about? That's not Europe.

That's the Europe that I love and know. All in the name of pretending to stop the global warming hoax. The entire globalist concept of asking successful industrialized nations to inflict pain on themselves and radically disrupt their entire societies must be rejected completely and totally, and it must be immediate.

That's why, in America, I withdrew from the fake Paris Climate Accord, where, by the way, America was paying so much more than every country. Others weren't paying. China didn't have to pay until 2030.

Russia was given an old standard that was easy to meet, the 1990 standard. but for the United States, we're supposed to pay like a trillion dollars. And I said, this is another scam.

The fact is, the United States has been taken advantage of by the world for many, many years, but not any longer, as you probably noticed. I unleashed massive energy production and signed historic executive orders to

hunt for oil. but we don't have to do much hunting because we have the most oil of any nation anywhere, oil and gas, in the world.

And if you add coal, we have the most oil in the country. Of any nation in the world. Clean -- I call it clean, beautiful coal.

You can do things today with coal that you couldn't have done 10 years ago, 15 years. So I have a little standing order in the White House. Never use the word coal.

Only use the words clean, beautiful coal -- sounds much better, doesn't it? but we stand ready to provide any country with abundant, affordable energy supplies if you need them, when most of you do. We're proudly exporting energy all over the world. We're now the largest exporter.

In the United States, we want trade and roust commerce with all nations, everybody. We want to help nations. We're going to help the nations.

but it must also be fair and reciprocal. The challenge with trade is much the same with climate. The countries that followed the rules and all their factories have been plundered, it's really sad to watch.

They've been broken. They've been broken. by countries that broke the rules. That's why the United States is now applying tariffs to other countries.

And much as these tariffs were, for many years, applied to us, uncontrollably applied to us. We've used tariffs as a defense mechanism under the Trump administration, including my first term, where hundreds of billions of dollars in tariffs were taken in. And by the way, we had the lowest inflation, and now we have very low inflation.

The only thing different is that we have hundreds of billions of dollars flowing into our country. but this is how we will ensure that the system works for everyone and is sustainable into the future. We're also using tariffs to defend our sovereignty and security throughout the world, including against nations that have taken advantage of former U.

S. administrations for decades, including the most corrupt, incompetent administration in history, the sleepy Joe Biden administration. Brazil now faces major tariffs in response to its unprecedented efforts to interfere in the rights and freedoms of our American citizens and others, with censorship, repression, weaponization, judicial corruption, and targeting of political critics in the United States.

I have a little problem saying this because I must tell you. I was walking in, and the leader of Brazil was walking out. We saw him, and I saw him.

He saw me, and we embraced. And then I'm saying, can you believe I'm going to be saying this in just two minutes? but we actually agreed that we would meet next week. We didn't have much time to talk, like about 20 seconds.

They were -- in retrospect. I'm glad I waited because this thing didn't work out too well. but we did talk.

We had a good talk, and we agreed to meet next week, if that's of interest. but he seemed like a very nice man, actually. He liked me.

I liked him. but if you -- and I only do business with people I like. I don't -- when I don't like them, I don't like them.

but we had, at least for about 39 seconds, we had excellent chemistry. It's a good sign. but also in the past, Brazil, can you believe this, unfairly tariffed our nation.

but now, because of our tariffs, we are hitting them back, and we're hitting them back very hard. As President, I will always defend our national sovereignty and the rights of American citizens, so I'm very sorry to say this, that Brazil is doing poorly and will continue to do poorly. They can only do well when they're working with us.

Without us, they will fail just as others have failed. It's true. Next year, the United States will celebrate the 250th anniversary of our glorious independence, a testament to enduring power in American freedom and spirit.

We will also be proudly hosting the 2026 FIFA World Cup. And shortly thereafter, the 2028 Olympics, which is going to be very exciting. I hope you all come.

I hope that countless people from all over the globe will take part of these great celebrations of liberty and human achievement, and that together we all can rejoice in the miracles of history that began in July 4th, 1776, when we founded the light to all nations. And it's something, really, that an amazing thing came out of that date. It's called the United States of America.

In honor of this momentous anniversary, I hope that all countries who find inspiration in our example will join us in renewing our commitment, values and those values, really that we hold so dear together. Let us defend free speech and free expression. Let us protect religious liberty, including for the most persecuted religion on the planet today.

It's called Christianity. And let us safeguard our sovereignty and cherish qualities that have made each of our nations so special, incredible, and extraordinary. In closing, I just want to repeat that immigration and the high cost of so-called green renewable energy is destroying a large part of the free world and a large of our planet.

Countries that cherish freedom are fading fast because of their policies on these two subjects. You need strong orders and traditional energy sources if you are going to be great again. Whether you have come from north or south, east or west, near or far, every leader in this beautiful hall today represents a rich culture, a noble history, and a proud heritage that makes each nation majestic and unique.

Unlike anything else in human history or any other place on the face of the Earth. From London to Lima, from Rome to Athens, from Paris to Seoul, from Cairo to Tokyo, and Amsterdam to right here in New York City, we stand on the shoulders of the leaders and legends, generals and giants, heroes and titans who won and built our beloved nations, all of our nations. With their own courage, strength, spirit, and skill, our ancestors climbed to mountains, conquered oceans, crossed deserts, and trekked over wide-open plains.

They charged into thunderous battles, plunged into grave dangers. And they were soldiers and farmers and workers and warriors and explorers and patriots. They built towns into cities, tries into kingdoms, ideas into industries and small islands into mighty empires.

You're a part of all of that. They were champions for their people who never gave up and who never, ever gave in. Their values defined our national identities.

Their visions forged our magnificent destiny. Everybody in this room is a part of it in your own way. That each of us inherits the deeds and the myths, the triumphs, the legacies of our own heroes and founders who so bravely showed us the way.

Our ancestors gave everything for homelands that they defended with pride, with sweat, with blood, with life, and with death. Now the righteous task of protecting the nations that they built belongs to each and every one of us. So together, let us uphold our sacred duty to our people and to our citizens.

Let us protect their orders, ensure their safety, preserve their cultures, treasure, and traditions, and fight, fight, fight for their precious dreams and their cherished freedoms. And in friendship and really a beautiful vision, let us all work together to build a right beautiful planet, a planet that we all share, a planet of peace and a world that is richer, better, and more beautiful than ever before. That can happen.

It will happen. It will happen, and I hope it can happen and start right now, right at this moment. We'll turn it around.

We're going to make our countries better, safer, more beautiful. We're going to take care of our people. Thank you very much.

It's been an honor. God bless the nations of the world. Thank you, very much, ye.
